We are continuously developing EmergencyEye to best support you and hereby inform you about the upcoming introduction of new features and changes.

We have just finalised the next leap in innovation as our team sprinted to deliver version 5.1.0 before Christmas. We assure you already today that the release 5.1.0 for the instances EmergencyEye® COMMAND, Videosupport.emeye-t.ch and all WhiteLabels and for all other EmergencyEye® instances of the emergency call and hazard prevention facilities will take place on 12.12.2022 by 12 o'clock.

New functions:

As news, we can now offer you the BIDI function. As usual, we will only make this function live after consultation with you and your administrators.

In addition, in Version 5.1.0 you will receive

1. a necessary GDPR banner when pressing the HD photo button (if this has been activated by you) and
2. an option for your administrators to adapt the session reports to your data protection requirements with regard to the scope of the reported information.

Important: After consultation with you, we will provide you with test and trial access to a full version of the EmergencyEye technology so that you can test new functions yourself outside your live platform and train your organisation on the new **BIDI** function before we activate it on your productive platform in consultation with you.

We will contact you in the coming days to coordinate this.

1. BIDI:

We all notice that during virtual interactions, the relationship between the parties can be built much better if the two parties also see each other.

Until now, it was possible for them to also see the persons on the smartphone by switching cameras.

With the **BIDI** (bidirectional image) function, it is now also possible for you to transfer your own image to the smartphone of the callers.



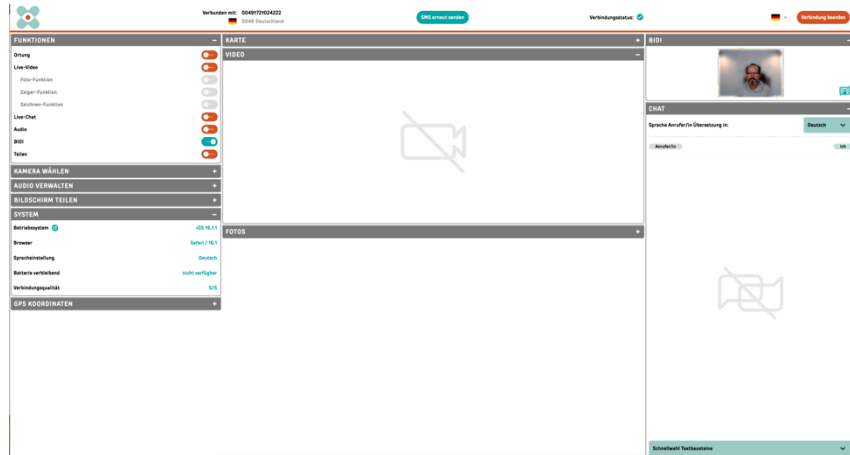
To do this, press the **BIDI** toggle.



and you will immediately see your own image in the top right-hand corner of the EmergencyEye dashboard. The background is initially blurred.

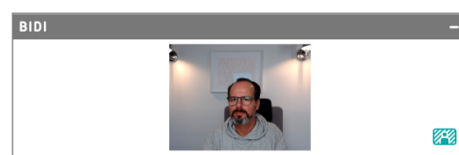


Smartphone

To the right of your own image you will find the button for a clear representation of your background.



You can undo this process at any time by pressing the "blur" button again. These actions are documented in the session report, see example:

2. Adjustments to the SessionReport:

There are different centre-specific requirements for the reporting of EmergencyEye sessions. Therefore, with version 5.1.0 we give your administrators the choice regarding the sections to be reported in the session reports, see also the following figure.

Here you can specify which information is documented in the session report.

Important: This selection concerns the entire centre.

3. GDPR banner:

Due to suggestions from users, we have decided to introduce a banner as standard when the HD photo button is pressed. This banner advises the user that when using the HD photo function, the caller should refrain from taking pictures of people if the situation does not absolutely require it.

This banner can be clicked away by pressing the OK button, but also disappears after 8 seconds.

This banner is displayed again as a reminder with each new HD photo request and does not affect the HD photo function.

The appearance, disappearance or active clicking away via the OK sign of the banner are documented in the SessionReport.
